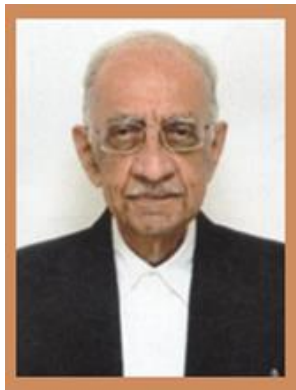

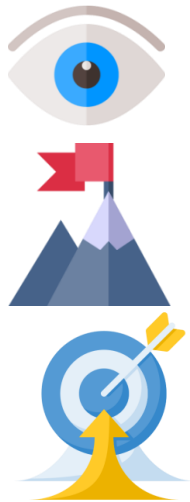

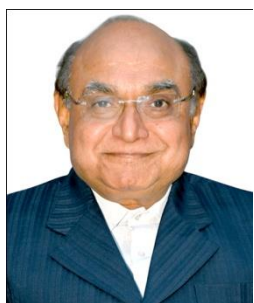
Introduction of the Mandal

Eligibility for admission

First Year Undergraduate:

Students who have passed Higher Secondary School Certificate Examination from the Maharashtra State Board of Secondary and Higher Secondary Education or equivalent shall be eligible for admission to B.Com. Part-I.

Second and Third Year Undergraduate:

Students who have passed B.Com. Part-I or Part-II or equivalent examination shall be admitted to the second year of the respective classes. Students promoted under ATKT rules are also eligible.

Environment Studies:

B.Com Part II Student will have to pass in the examination of this course in order to obtain degree certificate from University. In case the student remains absent or fails to clear the course in the second year, he will have to clear the course in the third year.

Rules for Admission:

The admission to the undergraduate class shall be according to the rules and regulations of the Rashtrasant Tukdoji Maharaj Nagpur University and the State Government.

(A) The original transfer certificate from the last educational institution attended is essential for admission. The certificate will not be returned once a student is admitted.

There will be no admission on the Duplicate Transfer Certificate.

(B) The fees once paid will not be refunded to the student who cancels his admission or leaves the college during the session.

(C) As per UGC norms, the sports persons shall be given preference in admission.

(D) The last date of admission to the college shall be according to the date fixed by Rashtrasant Tukdoji Maharaj Nagpur University.

(E) The decision of the Principal of the college regarding to the admission shall remain final.

Admission Process

Step 1	Submit physical documents (Original & Photocopies), Application and Fees in the college strictly accordance to schedule. Failure to complete the process, leads to cancellation of your name from merit list.
Step 2	Once original documents such as TC is submitted will not be returned or available in any case. Please keep sufficient number of photocopies of TC, Marksheet or any other document with you for future usage.
Step 3	Collect your college ID card/Entry Slip for the 1st day of college. Note down the timetable and college start date will be informed. It is mandatory to attend Induction Program of the College
Step 4	If applicable, the student has to complete the online Scholarship Process at his/her own responsibility
Step 5	Join the certificate courses for credit 4 to get a Certificate/Diploma
Step 6	Participate in activities conducted by the institution for CC subject Get associated with Alumni Association on before/after the completion of Graduation.

For further details and the application form, students should contact the College Office. The online application form should be filled out very carefully by the student. Be careful in filling the form and provide all details in the form as required.

1. Fill up complete form in every respect
2. Income certificate in detail, i.e. Basic pay, D.A., H.R.A. etc. for the last financial year

3. Mention whether the father is alive or not.
4. Leaving certificate
5. The signature of the father is required in ink.
6. If the father is alive, the father's /mother's signature is required.
7. If Income Tax is not paid, please attach a certificate that the father/ guardian is not an Income Tax payee
8. If father and mother live separately, a judicial separation certificate is to be attached
9. If the father is retired, Pension certificate is required
10. If caste is not mentioned in the School Leaving Certificate, students should not apply for G.O.I. (Government of India) Scholarship
11. Attested Marks List of Exam passed.
12. If parent's/guardian's income is below Rs. 1, 00,000/- per year (For BC/ NT/OBC), Rs. 2, 00,000/- per year for SC students should not apply for G.O.I. scholarship

The government may reject the form if it's not complete in every respect. College is not responsible for non-sanction of the scholarship. The student will have to pay full fees if GOI form is rejected or the student fail to fill up the form.

Scholarship / Concessions / Freeship

The following Scholarships/Concessions/Freeships are available:

1. Govt. of India Scholarship /E.B.C. concession/ Freeship / Rajeshri Shahu Maharaj open Category Scholarship
2. Minority Scholarship

In case of rejection of the scholarship application by govt /authorities, Full fees will be applicable.

Scholarship on Merit Basis

1. Students scoring more than 85% and above in XII (English medium) will get full fee concession in B.Com I
2. Students scoring more than 75-84.99% in XII (English medium) will get 50% fees concession in B.Com I
3. Students scoring more than 85% and above in B.Com I and II years will get full fee concession for next class.
4. Students scoring more than 75-84.99% in B.Com I and II years will get 50% fee concession for the next class.

Applicable /Payable Fees:

Important Note: The annual tuition fees for the First & Second year of Commerce faculty will be charged as prescribed by RTM Nagpur University. That can be changed as per modifications by University /Government.

- The student from University other than Rashtrasant Tukdoji Maharaj Nagpur University, She

will have to produce a Migration Certificate. The admission will be cancelled if the above requirement is not fulfilled within the said period.

- The candidate leaving the college in the middle of the session cannot obtain a Transfer Certificate unless she pays the fees for the complete session of the college.
- A duplicate College Transfer Certificate will be issued after producing the court affidavit. Based on selected services, other fees applicable: Examination fees, Security charges, self-finance program fees, Book bank deposit, Contributions for Academic / Study tour/ field visit, etc.

Awards:

College has constituted many awards for promising students they are as follows.

4. Library User Award: A award is constituted for the students who visits the library and reading room maximum number of times in the session.

University examination

As per the University rules 75% **attendance** in each subject is compulsory. Otherwise the student will be not been allowed to appear in the University examination. In such case, the college does not bear responsibility for the loss of one year of the student.

Library

The college has a library as well as a Reading Room. Books borrowed from Library should be handled with care and return within the specified time. If the book is lost or torn, the same will have to be replaced. The current cost of the book may be accepted under special circumstances.

Reading room

The college has a well-maintained Reading Room with English, Marathi, Hindi and Gujarati daily newspapers, weekly, fortnightly and monthly magazines. The magazines and journals are related to the subjects like Economics, Commerce, Science, Computer, Sports, Literature and General Knowledge. Entry into The Reading Room without the Identity Card is not permitted.

Medical test

A medical test is conducted by Nagpur University during January or February. The student who remains absent during this test can be disallowed from appearing in the University Examination. The college will not be responsible for the consequences of the absence in the test.

Parking facility

Students will have to pay Rs. 50/- for parking facility. The college will not be responsible for the theft of vehicles on campus. Locking of the parked vehicle is compulsory. Students should

have valid driving license with them.

Sports and Games Facility

Infrastructure for Sports and games is provided for indoor & outdoor games campus.

1. Indoor Games & Facilities: Chess, Carom, Badminton, Fitness Center
2. Outdoor Games & Facilities: Kabbaddi, Volleyball, Kho-Kho, Floorball

National Service Scheme (NSS)

“Education through Community Service” is the goal of NSS. College has 100 Cadets of NSS. Benefits (Marks) of NSS are applicable in accordance with the university norms.

Career Katta

Career Katta is an initiative of Department of Higher and Technical Education, Govt of Maharashtra and in coordination with Maharashtra Information Technology Support Centre. The college conducts various activities to guide students about Career, Competitive Examinations (UPSC, MPSC, Banking, SSB, SSC, Police, LIC, etc.), Entrepreneurship, Skill Development; Credit Earnings under new CBCS and NEP Curriculum Framework, Internship and Placement Opportunities, etc.

Eligibility to Join:

Any student admitted for any regular course in the college or college alumni referred by College Coordinator.

Registration Fees: One Time Rs. 365 for Three-year degree period (Rs. 0.36 per day), which will be reimbursed in the form of subsidy on examination charges of CBCS. It includes free access to all the activities, courses, State Level Competitive Exams, etc.

This is optional for students.

Committees & Cells

Some important committees in the institution are...

Internal Quality Assurance Cell (IQAC)

This cell has focused on quality parameters and standards through IQAS. The cell conducts regular surveys and feedback on curriculum, teaching learning, infrastructure, events and activities.

Anti-Ragging

College has zero tolerance policy against any sort of ragging or similar activities. Anti-Ragging Committee creates awareness among the students about ragging and its side effects. The committee is empowered to take strict and strong action in case such incidents are found.

Students' Grievance and Redressal Cell

College Grievance and Redressal Cell (CGRC) addressed all sorts of grievances raised by enrolled student of college. Committee resolves the grievance by following the principles of natural justice. ICC (Internal Complaints Committee)

The Institute has established an Internal Complaints Committee under the norms of UGC regulations 2015 to regulate Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and students in Higher Educational Institutions. Rules of Conduct of Students

1. Entry into the college premises without Identity Card is prohibited. The student must carry the Identity Card as long as they are in college premises.
2. Student should come to the college in full uniform.
3. Students must obey the orders issued by the Principal. Students will be held responsible for the misbehavior either in college premises or outside. She may be expelled from the college in case of indiscipline or rude behavior. It is presumed that the guardians know and agree to the rules while admitting their ward to the college.
4. The behavior of students toward teachers, office staff and the classmates should be proper. Otherwise strict action will be taken against students for the same.
5. Ragging is strictly prohibited. Immediate action will be taken against students / students found guilty of ragging, as per the Maharashtra State Rules
6. No student is allowed to publish any information regarding college administration in the newspaper without the prior permission of the Principal. Breach of this rule may result Expulsion of the student from the college.
7. The students should attend their classes regularly and should occupy their seats before the entry of the teacher in the classroom. They should not bring any person in the college premises who is not a student this college.
8. There should be perfect silence during the lecture in the class. The students should spend their leisure time in the Library, Reading Room or Student's Common Room without disturbing the working of the college. Loitering in the veranda is strictly prohibited.
9. The student should send the application for leave well in advance signed by her parents / guardian if she wants to remain absent on some ground. In case of ill health, if the absence is more than three days. She must submit the medical certificate certified by a Registered Medical Practitioner.
10. Students should not arrange any activity like an invitation to any person for the programme, picnic or formation of the committee without the prior permission of the Principal. Students must seek Principal's permission to arrange any academic or cultural activity, like Group Discussion or Debate etc.
11. It is expected that the student will be careful while handling instruments, apparatus, and utilizing electricity, furniture or any movable or, immovable property of the college. Strict action will be taken against the student in case of damage to the college property.
12. Only the special instructions are conveyed in the classroom. Hence, students should read the instructions on the notice board daily.
13. The student should inform the college office about the change in her permanent or local address.
14. The student should obtain the Identity Card immediately after the admission on submitting the recent passport size photograph (5x6.5cm) Payment of Rs. 50/- for the Identity Card is compulsory.
15. The student may be expelled from the college in case of copying or using unfair means in examination or violating any rules.
16. Rules regarding Games and Sports framed by the Committee must be followed compulsory.
17. Use of Mobile phone is prohibited in the college.
18. It is OBLIGATORY on the part of the student to follow the rules formulated by the Principal of the college from time to time. Principal's decision is final.
